2011-12 NAO Membership Categories

General NAO Membership Requirements

- Actively support the purpose and goals of the National AHEC Organization
- Uphold the NAO By-laws
- Pay annual dues established by the NAO Board of Directors

Basic Organizational Membership:

AHEC Program Office Dues - \$1,760 annually

Organizations at academic institutions that support a network of regional AHEC Centers in support of community-based health professions training programs, whether or not they currently receive Federal AHEC funding. This category of membership shall be considered an organizational member and have one voting privilege. AHEC Program Offices will receive 30 copies of the Journal of the National AHEC Organization annually.

AHEC Center Dues - \$640 annually

Organizations that maintain formal affiliation agreements with an AHEC Program Office. AHEC Centers that meet membership requirements but do not receive Federal funding and maintain an affiliation agreement may qualify for this category. This category of membership shall be considered an organizational member and have one voting privilege. Centers will receive 15 copies of the Journal of the National AHEC Organization annually.

Medallion Organizational Membership:

Silver: \$2,000 Annually Gold: \$2,500 Annually Platinum: \$3,000 Annually

AHEC Programs and Centers as described above that meet membership requirements. This category of membership shall be considered an organizational member and have one voting privilege. AHEC Program Offices will receive 30 copies and AHEC Centers will receive 15 copies of the Journal of the National AHEC Organization annually.

Silver NAO Members receive:

- Special recognition in the Journal of the National AHEC Organization
- Special recognition on the NAO Web site
- Special recognition in NAO Conference materials
- 10 (additional) copies of the Journal of the National AHEC Organization
- One free broadcast e-mail message to NAO members
- Discounted registration fees for NAO Conference

Gold NAO Members receive all Silver benefits, plus:

- Special recognition in four issues of the NAO eNews electronic newsletter
- One free ad (1/4-page) in one issue of the Journal of the National AHEC Organization

Platinum NAO Members receive all Gold benefits, plus:

- Spotlight article in one issue of eNews
- Special recognition at trade shows where NAO exhibits
- One free ad (1/2-page) in one issue of the Journal of the National AHEC Organization
- 50% discounted exhibitor space at one NAO Conference per member year

Student Dues - \$25 annually

A student or resident enrolled in a program affiliated with an AHEC. This category of membership shall not be considered an organizational member and shall have no voting privilege. Member will receive one copy of the Journal of the National AHEC Organization annually.

Affiliate Dues - \$250 annually

Governmental agencies, educational institutions, non-profit organizations, businesses or individual professionally affiliated with local or state level AHEC organizations. This category of membership shall not be considered an organizational member and shall have no voting privilege. Member will receive 5 copies the Journal of the National AHEC Organization annually.

Honorary/Emeritus

Individuals such as past Center or Program Directors, board members, faculty, advisory committee members and other community individuals at large, that maintain a relationship with an AHEC organization. This category of membership shall not be considered an organizational member and shall have no voting privilege. A nomination/request for this membership will be considered by the Membership Committee.
